**Session two: Services domain** 11:00-12:30 (1.5 hours), 3 May 2016

**About this annotated outline.** This outline has been prepared to provide an overview of key topics to be explored through the session's various presentations, interventions and discussions. It aims to guide the session's chair and speakers on the intended scope, timing and sequencing of interventions and provide participants an overview of the session. An annotation of each of the day's session is available.

## Rationale

This session looks in-depth to the domain on 'services' of the European framework for action on integrated health services delivery (FFA IHSD). The services domain sets out areas for action with the goal to ensure that the processes of selecting, designing, organizing, managing and improving services to optimize the performance of health services delivery are in alignment with the health needs of the population and individuals health systems aim to serve. Taking an integrated approach to services delivery is founded on the same principles as put forth in a primary health care approach for the delivery of comprehensive, coordinated, effective and patient-centred care. While the services delivery function is closely woven into and heavily determined by the other health system functions, a number of unique processes can be acted upon to strengthen the performance of health services delivery. This session aims to explore these different entry points and key areas for action to transform services delivery, these being put forward as: reorienting the model of care across the care continuum; organizing providers and settings of care; managing services delivery; and improving performance.
